2026 Proposed Budget

The draft 2026 budget, prepared by EISS, was reviewed alongside the 2017 WMP implementation forecast. Recommendations included:

- Removing inactive line items with \$0 allocations
- Increasing funding for municipal coordination, rules enforcement, and next-gen watershed planning
- Reducing administrative and miscellaneous lines
- Preparing benchmarking analysis of revenues/expenses with adjacent WDs and WMOs

Motion by Viswanathan to recommend the 2026 budget with discussed modifications to the full Board. Motion carried unanimously.

2026 Proposed Levy

The Committee reviewed the proposed 2026 levy and noted the upcoming public hearing.

Motion by Kuplic to direct the Administrator to update the hearing notice with revised 2026 budget details. Motion carried unanimously.
