Other Work

Seminary Fen Ravine Stabilization

When LMRWD staff conducted a field inspection near Seminary Fen to kick-off the gully inventory, we noticed that silt fence installed for the ravine stabilization project in 2016 had not been removed. The city of Chaska was informed that the fence was still in place. The District received notice on November 6th that the silt fence has been removed.

Watershed Based Funding

The Minnesota River North group met on November 4, 2020. Discussion centered on how projects would be ranked and what criteria should be in order to rank projects. Variables for criteria are to be edited by November 20, 2020. The total amount requested is 4X the amount available. The next meeting of the group is scheduled for 9:30am, December 21, 2020. Lower MN River North has been allocated \$673,699 for FY 2020/2021.

The Minnesota River South group held its 5th meeting September 18, 2020. Its 6th meeting is scheduled for November 20, 2020. The group agreed to allocate 15% to feasibility studies, 10% to education & outreach and 75% to on-the-ground projects. They also agreed that percentages be flexible so that they could be shifted depending on the projects that are submitted. Lower MN River South has been allocated \$829,075 for FY 2020/2021.

One Watershed One Plan - Planning Area 56

The last meeting of this group was September 15, 2020. The next meeting of this group has been scheduled for Tuesday, November 24th from 11:00 am to 1:00pm. There has been no agreement as to the boundaries of the planning area (Managers may remember there were a few different options). It is likely that the area will be those areas that do not currently have a watershed management plan, since many of the entities in the area want to be on an advisory group rather than on the planning committee.

Data Management

The date of completion for this project has been extended. The person assigned this project by the contractor has had some health issues, so a new person, Mariah Helgeson, has been assigned to the project. Mariah and I met virtually to discuss how to organize the District's data. We now have a list of meta-tags by which to categorize documents as they are stored. The next step is to determine a file structure and then determine which cloud service will work the best for the District. Board members should think about whether or not Managers want access to the database and what they would want access to. Mariah and I met on Tuesday, November 17, to discuss different options for cloud storage. The next step is to consult with Young Environmental to discuss how they will work with the LMRWD system.

2020 Financial Audit

On November 10, 2020, Redpath, (auditors for the LMRWD), Carver County Finance, (LMRWD financial services provider) and I met to discuss the 2020 audit of LMRWD finances. The audit is scheduled to be conducted the week of March 22, 2021.

Ike's Creek Chloride Monitoring

The US Fish & Wildlife Service (USFWS) has a "Friends of the Refuge" group that has been able to get funding from Cargill to support Chloride monitoring of Ike's Creek. USFWS has been discussing monitoring goals for Ike' Creek with the LMRWD and Chloride has been identified as the most urgent because of the plans the City of Bloomington has to develop that headwaters area of the Creek. LMRWD and USFWS have sporadically collected and tested samples, but sampling has not been consistent. The Metropolitan Council has agreed to collect and test samples regularly this winter. Since the Met Council and the LMRWD already have an agreement for monitoring Eagle Creek, it has been determined that an agreement for sampling and testing Ike's Creek between the LMRWD and the Met Council would be the easiest path forward. The LMRWD will then invoice USFWS Friends of the Refuge for reimbursement.

How's My Waterway

I joined a virtual meeting on November 17, 2020 to learn about a new portal the EPA has for the public to learn about quality around the country. The portal can be used to look up water quality in any neighborhood in the country. The portal can be found using this <u>link</u>. The information provided comes from various sources, but is mostly from the MPCA.
