Other Work

Dakota County Manager Solicitation

A mailing to all residential addresses in Dakota County was mailed December 17th. LMRWD Managers were added to the mailing list. I have received communications from two individuals that have expressed interest in the position.

60th Anniversary Video

A start-up committee of Eden Prairie journalists and community leaders formed by the Eden Prairie Community Foundation plans to fill the local news gap prompted by the closure of the *Eden Prairie News* last April. The committee named the initiative *Eden Prairie Local News* (EPLN) and is being incorporated as a non-profit, on-line, local news center with social media adjuncts. The reporter, Jeff Strate, who wrote the story about the LMRWD has been able to get play times on local cable access in several communities within the LMRWD. I have attached an email from Mr. Strate with air times in the different communities that are playing the video.

Watershed Based Funding

The Minnesota River North group met on Monday, December 21, 2020. The group determined that the LMRWD would receive \$100,000 for the Area #3 Project. I am working to get the application to BWSR by January 31, 2021. The District will have until March 31, 2021 to prepare the work plan. Lower MN River North has been allocated \$673,699 in total for FY 2020/2021.

In the Minnesota River South, BWSR determined that one of the projects approved by this group at its November 20, 2020 meeting did not qualify for funding. The group was asked to reconvene to decide which project should receive the funding allocated to the ineligible project. The amount of funding to be re-allocated was \$15,000. The group determined to fund a feasibility study of stormwater in the Credit River Watershed. There was some discussion as to whether or not the Credit River project would be eligible, since it was not currently in the Scott County WMO capital project program. If the project was ineligible because it was not in the Scott WMO Plan, the groups decided funds would go to the Scott County SWCD Lower Minnesota River Watershed Targeted TMDL Practice installations. Lower MN River South has been allocated \$829,075 for FY 2020/2021.

I did speak with the City of Shakopee about asking for the \$15,000 for downtown Shakopee BMPs, but we decided that \$15,000 amount was not sufficient cost benefit, with the additional reporting that is required with the grant.

Meeting notes and allocations are available (for both groups) if Managers wish to see them.

Data Management

The scope of work on the original proposal has been completed. There is still a balance on the contract and DRB Consulting will stay on this project to set up a file structure for LMRWD files to be transferred to Sharepoint. Della Young and I have talked about once the file system has been set up how we intend to transfer the files. We have discussed how an intern might be able to do this.

Ike's Creek Chloride Monitoring

The LMRWD received an agreement from MCES (Metropolitan Council Environmental Services) to begin taking sample of Ike's Creek for Chloride. MCES will be taking samples and testing them and the LMRWD will pay for the work provided by MCES. The LMRWD will receive funds from the Friends of the Minnesota Valley Refuge to pay for the work provided by MCES. The Friends of the Refuge will receive funds from Cargill to pay for the sampling and testing. The Agreement has been sent to legal counsel for review. Staff is working on an agreement between the Friends of the Refuge and the LMRWD. This will allow for regular sampling of the Ike's Creek. Previous sampling was done whenever USFWS staff had time to collect samples and send them for testing. The LMRWD paid for the cost of the testing.

Seminary Fen monitoring

The Seminary Fen Work Group met on December 22, 2020. The item that was discussed was sealing some wells that are prone to flooding and are owned by the LMRWD and located on private property. The private property owner has never had issues with the Carver WMO checking the water levels in the wells, however there had been some discussion that the LMRWD might want to get easements over the wells.

Carver WMO has observed that the area where these wells are located is prone to flooding and that consideration should be given to sealing them. It may be possible to use DNR equipment to save money, but the well owner (LMRWD) would be responsible for the cost of sealing.

The group also noted that the LMRWD has been collecting data from all of the observation wells within the fens in the District. The data collected has been entered into the State's STORET system; however no one has been analyzing the data that has been collected to determine trends.

As was noted in the previous administrator's report on this topic, new data loggers are needed at several of the wells. Options for logger replacements was discussed. It was noted that the more expensive option, around \$1,000 a piece, required significantly less time to collect and manage data.

Additional discussion included a prescribed burn to manage invasive species and the drain tile field in the peat dome. The DNR said there was a project that removed woody invasive and there are piles waiting to be burned this winter. There is additional removal that needs to occur before a prescribed burn can occur. The DNR staff agreed to talk about coordinating a burn.

LMRWD updated the group about the study of the fens the District has been doing and talked about the plan to study groundwater in the area. There was some discussion about the information about geology of the area found with the gaps analysis. The group discussed what each agencies is doing that may be a duplication of work that others are doing. The group determined to meet again in 3 to 4 months and to look at what is needed to fill in the gaps identified in the gaps analysis.
