In addition to items on the meeting agenda, the following District projects and issues were addressed during the month:

## **Other Work**

#### Salt Symposium

The Salt Symposium was held on August 3<sup>rd</sup> & 4<sup>th</sup>. It was well attended. Metrics about the number of people that joined the presentation were provided to the District in an email afterward. Even though they have been conducting the symposium for several years, they always seemed to find new information to present.

#### One Watershed One Plan Lower Minnesota River East

A meeting was scheduled for Thursday, August 19, 2021 to weigh in with city partners in the One Watershed One Plan (1W1P) planning process for the Lower MN River East. The meeting has been cancelled due to a lack of interest by the cities. A smaller group may meet to discuss models and tools to help develop the 1W1P.

#### **Nonylphenol Report**

Freshwater completed the report on nonylphenols and its ethoxylates. The report was provided to the Board and has been posted to the website. The report can be accessed on the website using this link. Carrie Jennings is planning to attend the September meeting to present the report and answer any question the Board may have.

#### Manager residency

Manager Raby informed the Board that he plans to resign from the Board and Manager Mraz has moved outside the boundaries of the LMRWD. State law requires that Managers be voting residents of the District and that if a Manager moves outside the boundaries of the District a vacancy exists on the Board. However, State Law also allows that Managers may continue to serve on the Board until a replacement is appointed by the County Board.

I consulted legal counsel because it seems there is a conflict in the statutory language with respect to whether Managers can continue serving on the Board if they do not reside in the District. This is the response from counsel; "Counsel reads the conflict in the statutory language most liberally to achieve the purpose and intent of the watershed law and to serve the best interest of the watershed district. The district must be allowed to function with a reasonable compliment of managers. The district for too long endured what I believe was dangerously unlawful with only two managers. In this case, I advise that Manager Mraz may continue to serve (at her discretion) until her replacement is appointed and qualified. The position, however, is vacant. The appointing county must be notified and make a reasonable effort to find a replacement. With this opinion, I also advise that Manager Mraz be notified that while she may continue to serve until her replacement is

appointed and qualified, she is not required to do so. In theory, if the county dragged its feet she could continue indefinitely – though I do not recommend this as a viable alternative to county appointment."

Manager Mraz was advised of this and would like to continue. I have also advised the appointing County, that Manager Mraz will continue, if she is willing, until a replacement is appointed, or her term expires.

I would suggest that Manager Raby be given the same option.

### **Highway 169 Coalition**

The Coalition had asked for assistance in arranging a tour of the Minnesota River. They wanted to begin at CHS and head upstream from there. None of the touring boats were willing to head upstream because of the low water levels and the navigation ends at the Savage terminals at River Mile Post 14.7. The Coalition was willing to tour downstream from CHS to hear a program about. The Coalition cancelled any tour this year because of the recent increase in COVID cases.

### Upper Mississippi River Basin Association (UMRBA)

Manager Salvato informed me that Rita Weaver from BWSR was scheduled to attend the quarterly meeting of the UMRBA to speak about the Water Storage Initiative. I joined the meeting to hear about BWSR plans to distribute the funds granted to this program by the legislature.

Ms. Weaver said BWSR was planning to seek input from stakeholders. I later communicated with Ms. Weaver that the LMRWD would be interested in being part of a stakeholder group. I also recommended several people familiar with the issues of the Minnesota River be invited to provide input, such as Dr. Carrie Jennings, Dr. Patrick Belmont and Dr. Karen Gran. All of these individuals were involved with the Collaborative Sediment Source Reduction project that was conducted by Dr. Peter Wilcox' group out of the University of Utah.

**MN River Corridor Plan:** Staff continues to work on this plan. The District is preparing to send out a survey to stakeholders and set up focus groups.

#### **Project Reviews**

The District discovered that the automated email system that was set up for permit application has not been working correctly since June 2, 2021. HDR, the District's webmaster was able to retrieve all emails that were sent and LMRWD has been able to manage all the application that were received in the intervening period.

**Canterbury Senior Living Center:** - City of Shakopee- This project is for a Senior Living facility in the Canterbury Park development area. Staff is reviewing the application

**MN Mash:** - City of Savage – This development will replace the Watermark project that was envisioned at the intersection of McColl Drive and Dakota Avenue South. A pre-application meeting has been scheduled for August 25, 2021

**Circle K/Holiday Station Store:** - City of Savage – An application was received for a Holiday gas station in Savage at 7800 126<sup>th</sup> Street. Staff is reviewing the application which is scheduled for consideration by the Board at the September 15, 2021 Board meeting.

**South Park Jeep:** - City of Burnsville - A building expansion is planned for the auto dealership at 1408 Highway 13 West in Burnsville. Staff is reviewing the application.

**Trunk Highway (TH) 55:** - MNDOT - Bloomington Road to TH 52, Mendota Heights - The LMRWD received an application for a permit to resurface the roadway, improve drainage, make pedestrian accessibility improvements and rehabilitate bridges on MN 55 from the east end of bridge over Bloomington Road in Minneapolis to junction US 52 in Inver Grove Heights and on I35E at MN 55 lighting and Construct restricted crossing intersection at Hwy 55 and Louis Lane in Eagan and extend turn lane at south junction Hwy 149. The District has received the 100% design plans and is reviewing them. **Burnsville Sanitary Landfill (BSL):** - City of Burnsville – (This information is from the July report) Waste Management has proposed to increase the permitted capacity of its BSL, reduce the footprint of the landfill and increase the permitted peak elevation of the landfill located along the Minnesota River in Burnsville. A portion of the BSL is unlined. The unlined portion of the BSL has been closed and capped. An Environmental Impact Statement was prepared in 2005. A supplemental EIS was released June 1, 2021 and was reviewed by LMRWD staff. LMRWD comments were sent to the MPCA and the comments are included in the July 21, 2021 meeting packet. **DEM-CON Landfill:** - City of Shakopee – (This information is from the July report) In late 2019, Great River Energy (GRE) closed its waste to energy plant in Elk River. Based on the amount of waste that was accommodated by GRE, the MPCA notified landfills located in the Twin Cities Metropolitan Area that applications for additional capacity were being accepted. Dem- Con landfill in Shakopee was one of four area landfills that submitted an application. (Waste Management's Burnsville Sanitary Landfill was another one of the four). There was a public meeting that discussed the process for determining Certificates of Need for metro-area landfills. You can view the meeting on YouTube using this <u>link</u>. An Environmental Impact Study will have to be prepared for this application.

**4905 TH Highway 13:** - City of Savage - Caribou Coffee has planned a new store at this location. The site is located within the 100 year floodplain. Permit approval of this project is on the August 2021 agenda.

**TH 169 Pedestrian Bridge:** - City of Shakopee – The LMRWD has not received an application for this project. A report on the wetland delineation and the no-loss application are in the July 21, 2021 meeting packet.

**2021 Safety & Security Center Phase 1: -** Metropolitan Airport Commission – There is no new information to report since the last update.

**106**<sup>th</sup> **Street Transportation Improvement Project:** - City of Bloomington – This project was conditionally approved at the June 2, 2021 Board meeting. The approval was for the improvements planned by the City of Bloomington. There are additional improvements being planned by MNDOT. The District is working to schedule a meeting with MNDOT to address the proposed drainage plan.

**Burnsville Cemetery Expansion:** - City of Burnsville - This project will expand the area available for burial plots by tree removal and re-grading. The Cemetery is located at 400 State Hwy 13 E. Staff is reviewing the application. No new information to report since last update.

**Capstone 35:** - City of Burnsville – This project was approved at the May 2021 Board meeting.

Jefferson Court: - City of Shakopee – This project was approved at the June 2, 2021 Board meeting.

**TH 41/CSAH 61:** - City of Chaska - This project is for transportation improvements to TH 41 in downtown Chaska, including the intersection of TH 41 with CSAH 61. No new information to report since last update.

**CSAH 61 Drainage Channel Extension:** - Carver County - The LMRWD received an application for this project which will alter the course of a channel that runs underneath CASH 61. This channel is the one that has been filling the box culvert with sediment. No new information to report since last update.

**494 River Bridge:** - 494 & MN River - This project is part of a MNDOT improvement project for I- 494. The project proposes to repairs bridges from 34th Avenue to TH 13 (including the 494 bridge over the MN River). It will widen and reconstruct the existing trail, replace lighting and deteriorated concrete median, repair concrete pavement and reconstruct bituminous shoulder. No new information to report since last update.

**Credit River Outfall Repair:** - City of Savage - This project is to repair the Credit River outfall where it daylights after going under TH 13 in Savage. There is no new information to report since the last update.

**Southbridge Crossing 6th Addition/Core Crossing:** - City of Shakopee - Permit approval for this project is on the July 2021 meeting agenda.

**Quarry Lake Park Improvements:** City of Shakopee – There are three components to this project; 1) a mountain bike trail in the southern portion of the site, 2) improvements to the park area and changes to accommodate the water-ski club and 3) an outlet of the lake to the Prior Lake Outlet Channel (PLOC). The City recently met with the LMRWD to discuss the permit for the outlet. **Prairie Heights:** City of Eden Prairie - This project is a residential housing development in Eden Prairie that is partially in the LMRWD and partially in Riley Purgatory Bluff Creek Watershed District (RPBCWD). It is not in a High Value Resource Area or the Steep Slope Overlay zone. Permitting authority was given to RPBCWD. No new information to report since the last update.

**MNDOT - I494 from TH169 to Minnesota River:** MNDOT – (This information if from the July report) MNDOT held a meeting on this project on July 7, 2021. This project has received partial funding and MNDOT plans to move forward are being developed. The project proposes to construct E-ZPass lanes (formerly MnPass lanes) and to eliminate flooding of freeway at Penn Avenue and between Nicollett Avenue and TH 77/Cedar Avenue. Penn Avenue stormwater will be directed to Penn Lake in Bloomington. Stormwater from freeway between I-35W and MN River will flow to underground storage that will control rate of stormwater release to the MN River. Initial will be replacement of bridges over I-494 between I-35W and MN River.




