

October 2021 Administrator report From: Linda Loomis, Administrator To: LMRWD Board of Managers

In addition to items on the meeting agenda, the following District projects and issues were addressed during the month:

#### **Other Work**

#### **Coalition for a Clean Minnesota River**

At the September 2021 LMRWD Board of Managers meeting, managers asked if there was a list of contributors to the work the LMRWD has helped fund to create a program for water storage. I have attached the lists of funding that Coalition for a Clean Minnesota River raised to match the LMRWD funding.

#### **Nichols Fen**

I participated in a discussion of Nichols Fen with the DNR. Nichols Fen is located in Dakota County. The Seneca Wastewater Treatment Plant is located in Eagan, near Nichols Fen. The Seneca Plant dewaters the area around the plant to reduce the hydrostatic pressure that could force underground tank up out of the ground. The DNR has determined that the groundwater pumping done by the WWTP is having a negative impact to Nichols Fen and is planning a mitigation plan. The plan, according to the DNR will be in the form of a financial mitigation.

#### **Limbo Creek**

The Board was asked about one year ago to join other organizations to request and Environmental Assessment (EAW) be prepared for a drainage project in Renville County. The Board declined to join others making that request. The issue involved a creek known locally as Limbo Creek. Normally, an EAW would be required for a drainage project of the type proposed, however, Renville County maintained an EAW was not required because Limbo Creek was not listed as a public water by the DNR. The DNR said that even though Limbo Creek was not on the public waters inventory, it still is a public water and should be treated as such. The issue has been litigated and the Minnesota Court of Appeals ruled in favor of the DNR and said Renville County must prepare an EAW. Renville County plans to appeal the appellate court decision to the Minnesota Supreme Court.

#### Lake Data on LMRWD website

Jen Dullum has been working on information about waterbodies in the LMRWD for the website. The first reports have been posted on the site for <u>Brickyard Clayhole</u>, <u>Courthouse Clayhole</u>, <u>Quarry (Shakopee)</u> and <u>Gifford Lakes</u>. The reports can be accessed by clicking on reports in the drop down menu under Resources, then going to Lakes.

#### **Watershed Plan Projects**

**Gully Inventory and condition assessment:** The final report is complete and final review is complete. The report will be available with the November 2021 meeting.

**East Chaska Creek: (Carver County Watershed Based Funding):** This project was visited during the October tour by the Board. Staff observed a significant amount of sediment at the upstream end of the project area; enough sediment that staff is concerned. The city and Carver County WMO will be consulted to discuss the situation. Signage is planned for this area. Staff will finalize reporting to BWSR, since a Clean Water Fund grant was received for this project under the Watershed Based Funding Program Pilot Program.

Schroeder Acres Park (Scott County Watershed Based Funding): LMRWD staff met with the city of Savage regarding this project. The LMRWD will contact BWSR to make sure the scope of the project as identified through the city's agreement with WSB fits the workplan that was reported to BWSR and to request a 6 month extension for the grant period.

Hennepin County Chloride Project (HHCl) (Hennepin County Watershed Based Funding): There are two projects funded under the Clean Water Fund Watershed Based Funding Pilot Program. One project is funds that have been pooled together by Watershed Districts in the Lower Minnesota River watershed. This project will fund winter maintenance equipment for local governmental units within the Lower Minnesota River Watershed. To date only Chaska has applied for funds under this program. The second program is a county wide program that is working to educate those that manage winter maintenance. This group has funded a demonstration project in the City of Plymouth, and they have prepared a winter maintenance management plan template for property managers. They are also working to develop a marketing plan and toolkit for targeting education for property managers. They also applied for an extension of the grant period until December 31, 2022.

**MN River Corridor Plan:** Staff continues to work on this plan. The survey was sent to LMRWD stakeholders. Responses have begun to come in.

#### **Project Reviews**

**CenterPoint Energy Nicollet River Crossing Segment 1 and CenterPoint Energy Nicollet River Crossing Segment 2:** – Cities of Bloomington and Burnsville – CenterPoint Energy is planning to replace its pipeline that extends under the Minnesota River. This permit application is on the October agenda.

**Excel Energy Line 0832:** - City of Burnsville – A permit for this project was approved at the September 2021 Board of Managers meeting.

**Lone Oak Signal:** - City of Eagan — The permit application for this project is on the October agenda.

**Canterbury Senior Living Center:** - City of Shakopee – A permit for this project was approved at the September 2021 Board of Managers meeting.

**MN Mash:** - City of Savage – This project impacts both a High Value Resource Area (Savage Fen) and the Steep Slope Overlay Zone. LMRWD staff met with the city, DNR, the proponent and consultants for the project, Tuesday, October 19<sup>th</sup>. The group discussed wetland mitigation for the site and then mitigation of impacts to Savage Fen.

**Circle K/Holiday Station Store:** - City of Savage — A permit for this project was conditionally approved at the September 2021 Board of Managers meeting. The LMRWD requested the proponent post a bond to assure final design of the stormwater management model met the District's requirements. Since the September meeting, staff has worked with the proponent and is satisfied that the stormwater management approach is acceptable. Staff plans to release the financial assurance.

**South Park Jeep: -** City of Burnsville – A permit for this project was approved at the September 2021 Board of Managers meeting.

**Trunk Highway (TH) 55:** - MNDOT - Bloomington Road to TH 52, Mendota Heights - The LMRWD received an application for a permit to resurface the roadway, improve drainage, make pedestrian accessibility improvements and rehabilitate bridges on MN 55 from the east end of bridge over Bloomington Road in Minneapolis to junction US 52 in Inver Grove Heights. There is no new information to report since the last update.

**2021 Safety & Security Center Phase 1: -** Metropolitan Airport Commission – The LMRWD received the plans for this project October 19, 2021.

**106**<sup>th</sup> **Street Transportation Improvement Project:** - City of Bloomington – This project was conditionally approved at the June 2, 2021 Board meeting. The approval was for the improvements planned by the City of Bloomington. There are additional improvements being planned by MNDOT. The District is working to schedule a meeting with MNDOT to address the proposed drainage plan.

**Burnsville Cemetery Expansion:** - City of Burnsville – The permit application for this project in on the October 2021 agenda.

Capstone 35: - City of Burnsville – This project was approved at the May 19, 2021 Board meeting.

Jefferson Court: - City of Shakopee – This project was approved at the June 2, 2021 Board meeting.

**TH 41/CSAH 61:** - City of Chaska - This project is for transportation improvements to TH 41 in downtown Chaska, including the intersection of TH 41 with CSAH 61. No new information to report since last update.

**CSAH 61 Drainage Channel Extension:** - Carver County – The permit application for this project is on the October 2021 Board of Manager meeting agenda.

**494 River Bridge:** - 494 & MN River - This project is part of a MNDOT improvement project for I- 494. The project proposes to repairs bridges from 34th Avenue to TH 13 (including the 494 bridge over the MN River). It will widen and reconstruct the existing trail, replace lighting and deteriorated concrete median, repair concrete pavement and reconstruct bituminous shoulder. No new information to report since last update.

**Credit River Outfall Repair: -** City of Savage - This project is to repair the Credit River outfall where it daylights after going under TH 13 in Savage. The city has applied for a public waters work permit for this project.

**Southbridge Crossing 6th Addition/Core Crossing:** - City of Shakopee – A permit for this project was approved at the July 21, 2021 Board of Managers meeting.
